The attached resolution authorizes FY26 funding up to a maximum of **\$2,422,695** from the **Community Mental Health Fund** for year three of the grant cycle for competitive grants and funding partnerships.

**RESOLUTION**

**WHEREAS**, the City of St. Louis, Missouri has levied taxes pursuant to the laws of the State of Missouri Sections 205.975 – 205.990 RSMo. to fund the Community Mental Health Fund (CMHF) and the Board is entrusted with administering this fund; and

**WHEREAS**, for FY26 a 3.3% cost of living adjustment (COLA) from current year tax revenue was available for continuation funding for all eligible Community Mental Health Fund FY26 project grants and partnerships up to \$2,422,695; and

**WHEREAS**, site visits, program and performance management, and fiscal monitoring have determined that all recommended Community Mental Health Fund projects and partnerships are on track to meet agreed-upon goals; and

**WHEREAS**, FY26 tax revenues are estimated to be sufficient to cover the recommended funding awards presented on the **attached spreadsheet**;

**NOW THEREFORE BE IT RESOLVED:**

The Trustees authorize and direct the Board Chair and Executive Director to enter into contracts with the organizations listed on the **attached spreadsheet** for funding in FY26 (July 1, 2025 - June 30, 2026) up to the amounts specified for each, not to exceed a maximum of \$2,422,695.
